# **RESOLUTION**

ТО

Providing for consideration of H.R. 2345 and for other purposes.

**B** E IT ENACTED by this House of Commons, in this present, assembled, and by the authority of the same, as follows: –

- 1 *Resolved,* that upon adoption of this resolution it shall be in order to
- 2 consider in the House the bill (H.R. 2345) the house renovation act of 2021.
- 3 All points of order against consideration of the bill are waived. An
- 4 amendment in the nature of a substitute consisting of the text printed in the
- 5 bill, modified by the Committee on Finance, accompanying this resolution,
- 6 shall be considered as adopted. The bill, as amended, shall be considered as
- 7 read. All points of order against provisions in the bill, as amended, are
- 8 waived. The previous question shall be considered as ordered on the bill,
- 9 as amended, and on any further amendment thereto, to final passage
- 10 without intervening motion except: (1) one hour of debate equally divided
- and controlled by the Chair and the Ranking Member of the Committee on
- 12 Finance or their respective designee; (2) the further amendments described
- in section 2 of this resolution; (3) the amendments en bloc described in
- section 3 of this resolution; and (4) one motion to recommit.

15 **SECTION 2.** After debate pursuant to the first section of this resolution,

- 16 each further amendment printed in part B of amendment paper 2102-12 not
- 17 earlier considered as part of amendments en bloc pursuant to section 3 of
- 18 this resolution shall be considered only in the order printed in the report,
- 19 may be offered only by a Member designed in the report, shall be
- 20 considered as read, shall be debatable for the time specified in the paper
- equally divided and controlled by the proponent and an opponent, may be
- 22 withdrawn by the proponent at any time before the question is put thereon,

- shall not be subject to amendment, and shall not be subject to a demand for
- 24 division of the question.
- 25 **SECTION 3.** It shall be in order at any time after debating pursuant to the
- <sup>26</sup> first section of the resolution for the chair of the Committee on Finance or
- <sup>27</sup> her designee to offer amendments en bloc consisting of further
- amendments printed in part B of amendment paper 2102-12 accompanying
- this resolution not earlier disposed of. Amendments en bloc offered
- <sup>30</sup> pursuant to this section shall be considered as read, shall be debatable for
- 30 minutes equally divided and controlled by the Chair and Ranking
- 32 Member of the Committee on Finance or their respective designee, shall not
- be subject to amendment, and shall not be subject to a demand for division
- of the question.
- 35 **SECTION 4.** All points of order against the further amendments printed in

the amendment paper 2102-12 or amendments en bloc described in section

- 37 3 of this resolution are waived.
- **SECTION 5.** (a) At any time through the legislative day of August 31, 2021,
- the Speaker may entertain motion offered by anyone that the House
- suspend the rules as though under clause 1 of rule XV with respect to
- 41 multiple measures described in subsection (b), and the Chair shall put the
- 42 question on any such motion without debate or intervening motion.
- (b) A measure referred to in subsection (a) includes any measure that was
- the object of a motion to suspend the rules on the legislative day of August
- 45 1, 2021 through August 31, 2021, in the form as so offered, on which the
- 46 yeas and nays were ordered and further proceedings postponed pursuant
- to section 4(e)(1) of House Resolution 1.
- (c) Upon offering of motion pursuant to subsection (a) concerning multiple
- 49 measures, the ordering of the yeas and nays on postponed motions to
- <sup>50</sup> suspend the rules with respect to such measures is vacated to the end that
- all such motions are considered as withdrawn.
- 52 **SECTION 6.** Notwithstanding section 4(e)(1) of House Resolution 1,
- <sup>53</sup> further proceedings on a vote by the yeas and nays on the question of
- <sup>54</sup> adoption of a motion that the House suspend the rules offered of any

- <sup>55</sup> legislative day from August 1, 2021 through August 31, 2021, may continue
- to be postponed through the legislative day of September 22, 2021.
- 57 **SECTION 7.** Without objection, the Journal of Proceedings are agreed to.
