**B**E IT ENACTED by this House of Commons, in this present, assembled, and by the authority of the same, as follows:—

1 **SECTION 1. Title.**

2 (a) This Act may be called “The Rules and Reform Act”.

3 **SECTION 2. Committee name.**

4 (a) The Committee shall be called “The Committee on  
5 Rules & Reform”.

6 **SECTION 3. Members of the committee.**

7 (a) The Committee shall establish the process of  
8 appointing and confirming members to the Committee as  
9 described in HCC § 1-2(a)-3.

10 **SECTION 4. Hearings.**

11 (a) The Committee may meet when:

12 (i) A bill is either ordered by the Speaker or the  
13 Committee has passed a bill to the House floor —  
14 and:

15 (i) There are amendments to the bill for a  
16 vote on the House floor in which the Speaker  
17 of the Chair of the Committee has provided  
18 to the Rules & Reform Committee; or

19 (ii) The Speaker or Chair of the Committee  
20 on the bill asks for a debate rule regarding  
21 the bill.

22 (b) The Committee is not required to establish a rule (see  
23 § 6(a)) for every bill.

24 (c) The Committee can only meet before the bill is brought  
25 to the floor for consideration.

26 (d) The Committee can also meet for the purposes of  
27 legislation in respect to any bills in regards to House  
28 Rules.

29 (e) The Committee may subpoena members to testify or  
30 produce documents.

31 **SECTION 5. Resolution providing for consideration**  
32 **of the bill.**

33 (a) The Committee may submit a Resolution that provides  
34 for consideration of one or more bills.

35 (b) The Resolution shall have the debate rules for the  
36 bill(s).

37 **SECTION 6. Committee jurisdiction.**

38 (a) Establish the amount of time and control on debate for  
39 bills—Debate Rule.

40 (b) Establish any amendments to be ordered on the floor—  
41 Amendment Paper.

42 (c) Serve as a Committee with a legislative purpose in  
43 respect to legislation targeted with intent to change the  
44 Rules of the House.
