**B** E IT ENACTED *by this House of Commons with the advice and consent of the same, as follows:*

- 1 WHEREAS, Sarah Cavinder is a Member of the House.
- 2 WHEREAS, Sarah Cavinder has made several comments  
3 that are offensive by being sexually-charged in nature,  
4 lewd, and not based in any fact during House sessions and  
5 when the House is not in session.
- 6 WHEREAS, Rule XXII of the Rules of the House requires  
7 all Members of the House to act in a manner “that shall  
8 reflect creditably on the House.”
- 9 WHEREAS, Clause 1(a) of Rule X of the Rules of the  
10 House provides that debate “shall respectfully address the  
11 Speaker.”
- 12 WHEREAS, Clause 1(b) of Rule X of the Rules of the  
13 House provides that debate “shall be confined to the  
14 question under debate, avoiding personality.”
- 15 WHEREAS, Clause 4(b) of Rule X of the Rules of the  
16 House provides that “an offending Member shall be liable  
17 to censure or other such punishment as the House may  
18 consider proper.”

19 WHEREAS, the gentlewoman's comments are a clear  
20 violation of the Rules of the House and hence warrants  
21 the formal censure to ensure that we reflect creditability  
22 and hold Members of this House to a high standard.

23 *Resolved*, that—

24 (1) The House of Commons censures Sarah E.  
25 Cavinder, a Member of the House;

26 (2) Member Sarah E. Cavinder forthwith present  
27 herself in front of the House podium for the  
28 pronouncement of censure; and

29 (3) Member Sarah E. Cavinder is censured with the  
30 public reading of this resolution by the Speaker.
