PROVIDING FOR CONSIDERATION OF THE BILL, HR 9, AMENDEMENT TO THE HOUSE RENOVATION ACT OF 2021.

FEBRUARY 3, 2022.—Referred to the House Calendar and ordered printed.

LEO CAVINDER, from the Committee on Rules & Reform, submitted the following

REPORT

[To accompany H. Res. 22]

The Committee on Rules & Reform, having had under consideration House Resolution 22, report the same to the House with the recommendation that the Resolution be adopted.

SUMMARY OF PROVISIONS OF THE RESOLUTION

The Resolution provides for consideration of HR 9, Amendment to House Renovation Act of 2021 under certain special rules. Permits the Speaker to declare the House resolved into the Committee of the Whole for HR 9 only. Provides for dispense of the first readings and waives all points of order against consideration. Provides that debate be confined to the bill and shall not exceed one hour divided and controlled by a proponent and opponent. Provides that the bill be subject to amendment as provided under the five-minute rule. The amendment in the nature of a substitute agreed to by the Committee printed in Part A shall be considered as adopted in the House and in the Committee. The amended bill shall be considered as the original bill for the purpose of further amendment under the five-minute rule and shall be considered as read. All points of order against provisions in the bill are waived.

Provides that there be no further amendments to the bill except the ones provides in Part B of this Report. Each amendment may be offered only in the order printed in the Report, offered only be a Member designated in the Report, shall be considered as read, shall be debatable for the period specified equally divided and controlled by a proponent and opponent, shall not be subject to amendment, shall not be subject to a demand for division of the question in the House or in Committee. All points of order against such further amendment are waived. At the conclusion of consideration of the bill for amendment, the Committee shall rise and report the bill to the House with such further amendments as may have been adopted. The previous question shall be considered as ordered on the bill. Any further amendments thereto to final passage without intervening motion except one motion to recommit with or without instructions.

EXPLANATION OF WAIVERS

The waiver of all points of order against considered of HR 9 includes waivers of the following:

 Clause 3 of Rule XII, which prohibits bills or resolutions that fail to meet a certain criterion as described in the Rule.

Although the Resolution waives all points of order against provisions in the bill, as amended, the Committee is not aware of any points of order. The waiver is prophylactic in nature.

Although the Resolution waives all points of order against the amendments printed in Part B of this Report, the Committee is not aware of any points of order. The waiver is prophylactic in nature.

SUMMARY OF THE AMENDMENT IN PART A CONSIDERED AS ADOPTED

1. LEO: Strike Section 2 and re-number as necessary.

PART A - TEXT OF AMENDEMENT CONSIDERED AS ADOPTED

SECTION 1. Title.

(a) This Act may be cited as "Amendment to House Renovation Act of 2021."

SECTION 2. Bathroom change.

- (a) Amend HCC § 3-1-7(a) by inserting the following:
- (iii) Close off upstairs bathroom connected to Master Bedroom—renovate as necessary.

SECTION 3. Master bedroom closet change.

- (a) Amend HCC § 3-1-18 by inserting the following:
- (c) The closet in the Master Bedroom shall be expanded out by using space from the upstairs bathroom.

SECTION 4. Additional amendment.

- (a) Amend HCC § 3-1-16(a) by striking all, and inserting:
- (a) Vinyl siding in a color to be determined by the House.

PART B - TEXT OF AMENDMENTS MADE IN ORDER

1. AN AMENDMENT TO BE OFFERED BY LEO CAVINDER OR HIS DESIGNEE, DEBATEABLE FOR 10 MINUTES.

Add the following after Section 4(a) of this Act:

(b) Expand the west side of the House upstairs with the Speaker's Room and Sarah's.

- (i) Use new additional space for closet and bathroom space; and
- (ii) Strike HCC § 3-1-6 in full.

2. AN AMENDMENT TO BE OFFERED BY TIM CAVINDER OR HIS DESIGNEE, DEBATEABLE FOR 10 MINUTES.

Add the following section to the Act:

SECTION 5. Upstairs changes.

- (a) The House permits the installation of infrastructure necessary to makes changes upstairs.
- (b) This Section of the Act shall not be in effect until the Speaker of the House moves out:
 - (i) The respective Speaker's Room, upstairs, shall be dissolved of.
 - (ii) The room shall be divided into a:
 - (i) Office Space;
 - (ii) Bathroom—Addition; and
 - (iii) Closet.

Strike and replace Section 2(a)(iii) of the Act:

(iii) Upstairs bathroom shall be connected to the hallway and the master bedroom—renovate as necessary.
