The Committee on Rules & Reform, having had under consideration House Resolution 28, report the same to the House with the recommendation that the Resolution be adopted.

SUMMARY OF PROVISIONS OF THE RESOLUTION

The Resolution provides for consideration of HR 16, Limited Amendments to the House Renovation Act under certain special rules. Upon the adoption of this Resolution, the House may call up the bill. All points of order against consideration of the bill are waived.

In lieu of the amendment ordered as the amendment in the nature of a substitute consisting of the text printed in Part B of this Report, shall be considered as adopted. The bill, as amended, shall be considered as read. All points of order against provisions in the bill, as amended, are waived.

The previous question shall be considered as ordered on the bill, as amended, and on any further amendment thereto, to final passage, without intervening motion except one hour of debate between the Chair and Ranking Member of the Committee on Rules & Reform or

their respective designees and one motion to recommit.

In addition, this Resolution permits the House to consider legislation read for the first time in the House as long as no objection exists. This clause is in effect until March 31, 2022.

PART A - TEXT OF AMENDEMENT CONSIDERED AS ADOPTED

SECTION 1. Title.

(a) This Act may be cited as "Amendment to House Renovation Act of 2021."

SECTION 2. Bathroom change.

- (a) Amend HCC § 3-1-7(a) by inserting the following:
- (iii) Renovate upstairs bathroom as necessary and have a connection to the Master Bedroom and the hallway.

SECTION 3. Master bedroom closet change.

- (a) Amend HCC § 3-1-18 by inserting the following:
- (c) The closet in the Master Bedroom shall be expanded out by using space from the upstairs bathroom.

SECTION 4. Additional amendment.

- (a) Amend HCC § 3-1-16(a) by striking all, and inserting:
- (a) Vinyl siding in a color to be determined by the House.

SECTION 5. Basement room.

- (a) Amend HCC § 3-1-11(c) by striking all, and inserting:
- (c) Office/Workout Space This space shall be an office for whom may like and shall also serve as a workout space.
