HR 30 – Contractor Standards and Accountability Act (CSAA)

1. Structured Rule for HR 30;
2. Provides one hour of general debate equally divided and controlled by a proponent and opponent or their designees;
3. Waives all points of order against consideration of the bill;
4. Provides that amendments printed in Part A of House Report 222-01 shall be considered as adopted and the bill, as amended, shall be considered as read;
5. Waives all points of order against provisions in the bill, as amended;
6. Provides that following debate, each further amendment printed in Part B of House Report 222-01 report not earlier considered as part amendments en bloc pursuant to section 3 shall be considered only in the order printed in the report, may be offered only by a Member designated in the report, shall be considered as read, shall be debatable for the time specified in the report equally divided and controlled by the proponent and an opponent, may be withdrawn by the proponent at any time before the question is put thereon, shall not be subject to amendment, and shall not be subject to a demand for division of the question;
7. Section 3 provides that at any time after debate the chair of the Committee on Rules & Reform or his designee may offer amendments en bloc consisting of further amendments printed in Part B of House Report 222-01 report not earlier disposed of. Amendments en bloc shall be considered as read, shall be debatable for 30 minutes equally divided and controlled by a proponent and an opponent or their designees, shall not be subject to amendment, and shall not be subject to a demand for division of the question; and
8. Waives all points of order against the amendments printed in Part B of the report and amendments en bloc described in Section 3 of this Resolution.

RESOLUTION

Resolved, that upon the adoption of this resolution it shall be in order to consider in the House the bill (HR 30) the Contractor Standards and Accountability Act (CSAA). All points of order against consideration of the bill are waived. The amendments printed in Part A of House Report 222-01, shall be considered as adopted. The bill, as amended, shall be considered as read. All points of order against provisions in the bill, as amended, are waived. The previous question shall

be considered as ordered on the bill, as amended, and on any further amendment thereto, to final passage without intervening motion except: (1) one hour of debate equally divided and controlled by a proponent and opponent to the bill or their respective designees; (2) the further amendments described in Section 2 of this resolution; (3) the amendments en bloc described in section 3 of this resolution; and (4) one motion to recommit.

Sec. 2. After debate pursuant to the first section of this resolution, each further amendment printed in Part B of the report of the Committee on Rules & Reform accompanying this resolution not earlier considered as part of the amendments en bloc pursuant to section 3 of this resolution shall be considered only in the order printed in the report, may be offered only by a Member designed in the report, shall be considered as read, shall be debatable for the time specified in the report equally divided and controlled by the proponent and an opponent, may be withdrawn by the proponent at any time before the question is put thereon, shall not be subject to amendment, and shall not be subject to a demand for division of the question.

Sec. 3. It shall be in order at any time after debate pursuant to the first section of this resolution for the chair of the Committee on Rules & Reform or his designee to offer amendments en bloc consisting of further amendments printed in Part B of the report of the Committee on Rules & Reform accompanying this resolution not earlier disposed of. Amendments en bloc offered pursuant to this section shall be considered as read, shall be debatable for 30 minutes equally divided and controlled by a proponent and an opponent or their respective designees, shall not be subject to amendment, and shall not be subject to a demand for division of the question.

Sec. 4. All points of order against the further amendments printed in Part B of the report of the Committee on Rules & Reform or amendments en bloc as described in section 3 of this resolution are waived.
